

Certificate of professional liability

We hereby confirm that the Order of Flemish Bar Associations has entered into a civil-law professional liability insurance with the purpose of safeguarding the insured parties against the monetary consequences of the contractual and non-contractual civil-law liability resulting from damage or loss suffered by third parties, including their clients, in the performance of their profession. The insurance does not cover any acts performed or facts occurring after the lawyer was deleted from the list of lawyers or trainees.

- The lawyers included in the list of lawyers or trainees of the Order of Flemish Bar Associations, or included in a EU list, provided that they subscribed the policy
